Terms and Conditions :-

- 1) The school must comply with all the provisions of the Right of Children to Free and Compulsory Education Act, 2009.
- 2) The permission given to establish schools as per the provisions of this Act will be from the academic year 2024-25.
- 3) If the management does not start the school within eighteen months of receiving the permission, the permission will be deemed to be cancelled.
- 4) While granting residence, it will be mandatory for your new school to follow the procedures of the government orders issued from time to time as well as all the provisions of the Right of Children to Free and Compulsory Education Act, 2009 and the Maharashtra Self-Aided Schools (Establishment and Regulation) Act, 2012 (1 of 2013).
- 5) No changes can be made in the medium, location, etc., requested by the organization for school permission in the future. If a school is started at a place other than the place for which permission has been granted by the government, the permission granted by the government will automatically be considered cancelled.
- 6) It will be mandatory to put up a signboard indicating that the new school/class is eligible for permission on self-financing basis for the information of all the public in the facade of the school building. It will be mandatory to write "self-financing school/class" on the eligible transactions made from time to time.
- 7) Schools which have been granted first account recognition under the Maharashtra Self-Financed Schools (Establishment and Regulation) Act, 2012, cannot be shifted to another location in the future.
- 8) Schools recognized under the Maharashtra Self-Financed Schools (Establishment and Regulation) Act, 2012 will be required to be recorded as self-financed schools/classes while filling information in UDIS.
- 9) Recruitment of teachers and non-teaching staff in permitted self-financed schools should be done as per the prevailing rules and policies of the government.

It will be mandatory for the Government to implement the existing rules and such rules as the Government may issue from time to time.

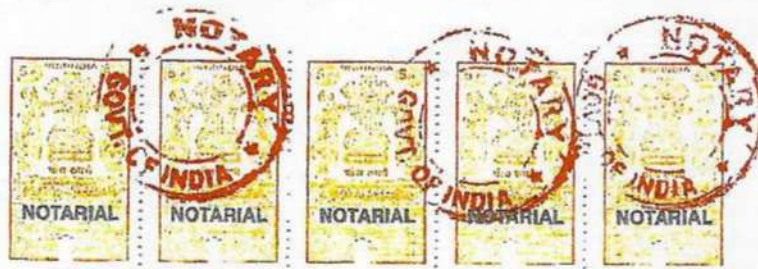


